UPCOMING CHANGES TO THE CHAPTER 33 OR "FOREVER GI BILL" AKA POST 9/11

•	Assistance for students affected by school closures and certain program disapprovals
	Students may be able to receive back entitlement charged against them if their school closed while they were attending immediately
•	Elimination of 15-year time limit to use the post-9/11 GI bill
•	The law removes the 15-year time limit for the use of post-9/11 Gl bill benefit for those whose last discharge or release from active dury is on or after January 1, 2013, children of deceased servicemembers who became entitled to post-9/11 Gl bill benefit on or after January 1, 2013, and all spouses using fry scholarship. Immediately


- Changes To Survivors' And Dependents' Educational Assistance
- The New Law Decreases The Amount Of Entitlement That New Eligible Individuals Will Receive Under The Survivors' And Dependents' Educational Assistance (DEA) Program From 45 Months To 36 Months.
 August 1, 2018
- Changes To Transfer Of Benefit (TEB) January 2020
- Veterans Who Transferred Entitlement To A Dependent Can Now Designate A New Dependent If The Original Dependent Dies. If The Veteran Dies, A Dependent Who Received Transferred Entitlement Can Now Designate A New Eligible Dependent Of The Veteran To Transfer Any Of The Dependent's Remaining Entitlement. August 1, 2018

Monthly Housing Based On Campus Where Student Attends Most Classes

 The Law Requires The Monthly Housing Allowance Under The Post-9/11 GI Bill Program To Be Calculated Based On The Zip Code Of The Campus Where The Student Physically Attends The Majority Of Classes, Rather Than The Location Of The School Where The Student Is Enrolled. August 1, 2018

• Purple Heart Recipients

 Servicemembers And Honorably Discharged Veterans Who Were Awarded A Purple Heart On Or After September 11, 2001, Will Be Entitled To Post-9/11 GI Bill Benefits At The 100-percent Benefit Level For Up To 36 Months. August 1, 2018





Veteran and Student Veteran Statistics



 Student Veterans Have The Potential To Succeed. As Documented In A Report From The National Veteran Education Tracker (NVEST) Project, Post-9/11 Veterans Have The Potential To Succeed At High-graduation-rate Institutions. Student Veterans Are 1.4 Times More Likely To Earn A Certificate Or Degree Than Adult Learners Overall, And Student Veterans Have An Average GPA Of 3.34, Compared To The Average For Traditional Students Of 2.94

- Have a disability
- Work full or part-time

Student Veteran Statistics

- Most Of Us Are Between The Ages Of 25 To 34 (43%)
- They Come From A Host Of Different Backgrounds And Cultures.
- The Great Majority Of Us Served In The Enlisted Ranks Of The Military (82%)
- Were a Member Of The U.S. Army (47%)
- Served In The Navy (18%) Served in the Air Force (21%),
- Served in the Marine Corps (12%)
- 2 Percent Served In The U.S. Coast Guard
- Many Are Civilian-soldiers-members Of The National Guard Or The Reserves (45%)

Student Veterans Attributes and Strengths



- Served The Nation During A Time Of War, And Because Of That, I Likely Deployed Overseas.
- More Than 3 Million have Deployed To Iraq And Afghanistan Since 9/11
- Many have Deployed Multiple Times On Average
- Probably Spent One Out Of Every Three Years Of Military Life Away From The United States and Family
